3. Responsibilities:

Responsibilities of the College:

The College agrees to:

- Provide necessary infrastructure, including computers/laptops and mobile devices, for student participation.

Responsibilities of the Company:

The Company agrees to:

- Award certifications to students upon successful completion of the program.

4. Fees Structure:
