

## MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding "MOU" is made and entered into, at Greater Noida on the 28 hammaday of November 2023.

BETWEEN

Inlingua, International School of Languages, Greater Noida Centre and has its office at Parsavnath Bhibab Plaza, Office no 22, Alpha 1 Commercial Belt, Greater Noida (hereinafter referred to as the First Party, which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include

The Second Party represented herein by its Name of Vice Chairman, MANGALMAY Management

(hereinafter referred as 'Second Party, the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

Mangalmay Institute of Management and Technology, Greater Noida, Uttar Pradesh & Inlingua Greater Noida Centre hall hereinafter be also jointly referred to as the "Parties" and severally as the "Party"

Whereas, both Mangalmay Institute of Management and Technology, Greater Noida, Uttar Pradesh and Inlingua Greater Noida Centre have appreciated each other's objectives in promoting excellence in the Core English Training and are desirous of entering into an MOU for mutual benefit and advantage and have reached the following understanding.

NOW BOTH THE PARTIES HAVE REACHED TO THE FOLLOWING UNDERSTANDING / AGREEMENT, IN PRINCIPLE AGREEMENT OF COLLABORATION

- [1] Both the parties have identified the following areas where they agree to mutually co-operate to the

- [3.2] Provide Trainer: Inlingua Greater Noida will be responsible to provide a trainer for the said training.
- [3,3] Training content will be taken care of by the Inlingua Greater Noida Centre
- [4] Below are the Training deliverables as per the agreement.

Offline Training-

- [a] The Topics will be covered as mutually decided by faculties of Mangalmay College and Inlingua.
- [b] The session and costing details are given below:

- a) Name of Training Program: Cambridge English Test Training
- b) Duration: 30 hours
- c) Days of Training: Twice a week (Minimum 2 hours each day)
- d) Maximum Number of Students: 60-75
- e) Costing per hour: Rs.3000/-
- f) Total cost for 30 hours of Training: Rs.90000/-
- g) Mode of Payment: 50% Advance Payment before commencement of training. Balance 50% on completion of training.

[B]

- (a) Name of Training Program: English Communication Training
- b) Duration: 30 hours
- c) Days of Training: Twice a week (Minimum 2 hours each day)
- d) Maximum Number of Students: 60-75
- e) Costing per hour: Rs.2500/-
- f) Total cost for 30 hours of Training: Rs.75000 /-
- g) Mode of Payment: 50% Advance Payment before commencement of training. Balance 50% on completion of training.

[C]

- a) Assessment Test Charges: Rs.100/- per Student Rs.11200/- for 112 Students.[ Already Completed]
- b) Certificate Issuance Charges: Rs.50/- per Certificate.

Tools like projector, Audio system for training purposes will be provided by the secondParty.

Any further requirement would also be treated as a part of this understanding and the scope of the work would be separately created as an addendum to this MoU.

None of the Parties shall use, register, or attempt to register any of the Intellectual Property
Rights which the party knows vests in the other Party, without the written permission of such
Party. Written permission shall be deemed to have been granted in the event of no written revert
within 30 business days of intimation of the intent to register any Intellectual Property Rights. Any
use of the Intellectual Property Right of one Party in course of achieving the objectives shall not
be deemed to vest the ownership of the Intellectual Property Rights in the other Party. Any
unauthorized attempt to use, register or attempt to register any of the Intellectual Property Right
of a Party without the express permission of the other Party shall constitute an act of
infringement of the Intellectual Property Rights of the said Party.

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants set forth herein, the Parties hereto agree as follows for phase 2 of the understanding:

2<sup>nd</sup> party is ready to allow 1<sup>st</sup> party to conduct the training program at 2<sup>nd</sup> party premise and extend all the support mentioned above.
