A meeting of the Anti Ragging Committee was held on 05-07-2023 at 3:00 PM in the Board Room to deliberate on the following agendas:


1. To approve the minutes of the previous meeting dated 07.02.2023.

- All the safety & security measures were monitored regularly.
- Faculty members informally interacted with students to sensitize them on the ill effects of ragging.

3. ARC Action Plan for 2023-24

Following plan of action by the ARC for Academic Session 2023-24 was put up to the house and the same was approved after discussion:

- a. Students must be educated about the negative impact of ragging through informal & formal interactions.
- b. Awareness campaigns should be carried out in the institute in the following way-
 - Anti-Ragging Committee should plan briefing session in orientation program.
 - Awareness program like: Nukkad Natak,, chit-chat over chai, movie-screening on anti-ragging activities should be organized to create awareness among students.
 - Poster making competition to be organized on anti ragging theme.
- c. Random visits to the hostel and other places should be frequented by the anti-ragging squad.
- d. Strict adherence to all the anti-ragging regulations.
- e. It should be ensured that any anti-ragging complaints should be resolved swiftly and completely.
